Subject: Resolution Adopting a Fee Schedule for the City of Marshall Swimming Pool

This item is related to the Ordinance item on the agenda, which states that fees for the City of Marshall Swimming Pool will be set by Resolution of the City Commission. The City Attorney has prepared the Resolution, and a copy is attached.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF MARSHALL, TEXAS, SETTING THE USER FEES AT THE CITY OF MARSHALL SWIMMING POOL; FINDING THAT THE MEETING AT WHICH THIS RESOLUTION WAS PASSED WAS CONDUCTD IN STRICT COMPLIANCE WITH THE TEXAS OPEN MEETINGS ACT; REPEALING ALL ORDINANCES IN CONFLICT HEREWITH; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the City Commission has determined that setting fees and charges at the City Pool by resolution will save money and staff time by eliminating the need for continual updates to the Code of Ordinances to reflect changes in such fees and charges;

WHEREAS, the City Commission has amended Section 21A-12 of the Code of Ordinances of the City of Marshall, Texas, to allow the Swimming Pool fees to be set by resolution of the Commission; and,

WHEREAS, the City Commission desires to adopt fees and charges that are fair and reasonable to the citizens who use this City facility; **NOW, THEREFORE**,

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF MARSHALL, TEXAS:

Section 1. That the findings set out in the preamble to this resolution are hereby in all things approved.

Section 2. Fees to be charged at the City Swimming Pool. In accordance with Section 21A-12 of the Code of Ordinances of the City of Marshall, Texas, the following fees and rates shall apply to the City Swimming Pool:

Rate schedule for 2015.

**Open Swim Sessions: \$2.00 per session for each person.
(Sessions to last for a minimum of 2 hours.)**

Lap Swim: \$10.00 per week for each person.

Swim Lessons: \$40.00 per person for each session (Session consists of 4 lessons)

Mommy & Me: \$40.00 per session (Session consists of 4 lessons)

Private Swim Lessons: \$15 per person for each session (1 lesson)

Section 3. That the meeting at which this resolution was passed was conducted in strict compliance with the Texas Open Meetings Act (Texas Government Code Chapter 551).

Section 4. That all other prior resolutions or portions of resolutions of the City of Marshall in conflict with the terms and provisions of this resolution are hereby repealed to the extent of such conflict only.

Section 5. That the repeal of any resolution or portion of a resolution by this resolution shall not affect the validity of any pending enforcement action or fees outstanding and due and payable for services rendered on or before the effective date of this resolution.

Section 6. That this resolution shall be effective on the ____ day of May, 2015.
