## Solid Waste Division

### CART LEASE ORDER FORM

Please review the following guidelines, complete the form, and return to address provided below. Reference: City of Marshall Code of Ordinances, Chapter 14 Sections 9 (c) - carts.

Customers provided solid waste and recycling services by the City of Marshall Solid Waste Division may lease 95 gallon rolling garbage or recycling carts for **\$2.00 each** per month.

The cart lease will become effective the date the cart is delivered and the \$2.00 fee per cart leased will be added to your next monthly City utility bill.

Leased carts are location specific and not transferable to another address without prior written approval of the City.

Leased carts are City property and are subject to replacement, repair, or alteration as determined by the City. Replacement of a cart because of normal use will be at no cost to the customer. However, if it is determined that a cart has been abused or misused, the leasing customer will be billed for the current replacement cost of the cart. The leasing customer is responsible for care and custody of their leased City cart(s).

Lost or stolen carts are the responsibility of the leasing customer and if not found, the customer will be responsible for the cost of replacement. To report a missing cart, contact the Public Works Office at 605 East End Blvd. South or call 903-935-4516. No credits or refunds will be issued for missing leased carts.

Applicants may discontinue their cart lease by visiting the Water Public Works Office at

605 East End Blvd. South or calling 903-935-4516 and the \$2.00 monthly fee/per cart lease fee will be discontinued as soon as the cart(s) are removed by City; leasing customer is responsible for cleaning the cart(s) prior to pick up. Unsanitary carts will not be removed by the City and charges will continue until the cart(s) are cleaned and removed by the City.

Failure to pay monthly water bill in a timely manner will result in suspension of cart service and cart removal.
