Election of Board Chair and Vice Chair in accordance with the board bylaws.

Section 6. OFFICERS

- a. Officers of the board shall consist of a Chair and Vice-Chair.
- b. Terms of the officers shall begin immediately upon vote of a quorum of the Board during its first regular meeting. Terms of selected officers shall be one (1) year.
- c. No officer shall serve more than two (2) consecutive one (l) year terms in the same appropriated position, although officers will be allowed to serve an additional one (1) year term after a one (1) year absence.
- d. The Chair shall preside over meetings of the board. The Chair shall serve as chief spokesperson by the board in all matters of the board outside its meetings.
- e. The Vice-Chair shall perform duties as delegated by the Chair and shall exercise the powers of the Chair in the event of absence or inability of the Chair to serve or preside over meetings of the board.

2020 HOT Funds Collection & Expense Report Report

2020 was a difficult year for Hotel Occupancy Tax collection in Marshall, but not terrible.

2021 HOT Funds Budget

Travel has been down in Texas and although it has picked up, the desire to travel is not as strong as it was pre-covid. This affects our bottom line. Staff was not present to make budget recommendations for 2021, but it is our recommendation that we work from roughly 15% - 20% less than the proposed expected HOT revenues for 2021 to be on the safe side. If there is a surplus towards the end of the year, staff will recommend to the board to have the City create a "rainy day fund" for Visit Marshall-setting aside a portion of the surplus to be prepared for future projects or unexpected financial situations.

HOT Fund Grants

Staff has yet to send out applications to perspective recipients. Even in the delay, we can back pay any organization who qualifies for funding.

For FY2021 Staff recommends funding \$40,000 in grant monies total for organizations who qualify. This is an increase of \$2,350 from 2020.

Staff will be updating applications and sending them to organizations by the end of January and will have them returned and ready to review by the board by the February meeting.
