IT IS EXPRESSLY UNDERSTOOD THAT THE CITY OF MARSHALL SHALL NOT BE RESPONSIBLE IN ANY DAMAGE OR ISSUES WITH THE CONTRACTORS EQUIPMENT THAT MAY RESULT FROM THE MOVEMENT OF THE ABOVE DESCRIBED VEHICLE/EQUIPMENT AND LOAD OVER CITY OF MARSHALL STREETS AND THAT ALL SUCH RESPONSIBILITY IS HEREBY ACCEPTED ON BEHALF OF THE APPLICANT.
